**GLOSSARY**

<b>Term</b>	<b>Definition</b>
Accommodation	One accommodation unit where train category or class is specified.
Assistance dog	A dog that has been or is being trained as a guide dog, hearing dog or service dog and is in service/in duty during the travel.
Cancellation fee	The fee of service supplier company in case of refund
Carrier	See contractual carrier.
Choice of route	When there is a choice of route, the journey must be made by one of the routes shown.
CIT	International Rail Transport Committee [Comité international des transports ferroviaires].
CIV Uniform Rules	Uniform Rules concerning the Contract of International Carriage of Passengers by Rail.
Class	Service level of travel with defined comfort (e.g., Business, 1st class, 2nd class).
Couchette compartment	A couchette compartment contains maximum 6 beds.
Contract of carriage	<p>A contract between carrier(s) and passenger which obliges the carrier(s) taking part in the performance of the contract of carriage to carry the passenger from the place of departure to the place of destination.</p> <p>Contract(s) of carriage are documented by ticket(s).</p> <p>Tickets act as prima facie evidence of the conclusion and content of the contract of carriage.</p> <p>However, irregularity or loss of the ticket shall not affect the existence or validity of the contract which shall remain subject to the CIV (Article 6 CIV).</p>
Contractual Carrier	<p>An organisation [by or] on behalf of whom a contract of carriage has been concluded whether the carriage is actually performed by that organisation or by a substitute carrier; in cases of a through- ticket several carriers co-operate as → successive carriers. Then every carrier is responsible for its part [leg] of the journey only.</p> <p>The contractual carrier or successive carriers are indicated on the ticket by their RICS codes. Substitute carriers are not indicated on the ticket</p>
Cross referencing	Technology which allows documents which are marked as being a through ticket (single contract of carriage) by using electronic document numbering 1/3, 2/3, 3/3. The term “page numbering” is used in UIC leaflet 918-2.
Customer	<p>The activity undertaken in buying the ticket in the name of and for the benefit of the passenger. This entity may differ from a passenger.</p> <p>This entity may differ from a passenger, e.g., company A buys a ticket for a business trip of its employee B. Then A is the customer, B is the passenger. It must be defined who is entitled to which passenger right(s).</p>
Destination point	Railway station, bus station or a port. Includes stops of trains, buses or vessels. Destination point may also be a specific region, a specific country or a border point.

Domestic section	A section which only involves one country.
Domestic ticket in foreign sales	Ticket which is issued by an issuer for domestic routes in another country. See also “international ticket”.
e-ticket	Ticket held as an electronic data record capable of being transformed into legible written symbols. Several data records form a single contract of carriage when they are issued as a single (through) ticket in accordance with MIRT.
EWT	East West traffic Tickets
General Conditions of Carriage (GCC)	General Conditions of the carrier(s) prepared in the form of general terms and conditions or tariffs legally in force in each railway undertaking or shipping company and which become, by the conclusion of the contract of carriage, an integral part of it.

Handling fee	The fee of ticket issuer's in case of refund
IRT (Integrated Reservation Ticket)	Ticket in which compulsory reservations for a specific train is integrated. An IRT can only be issued to/from scheduled stations.
International ticket	Ticket which is issued for continuous sections in at least two countries or from a border point to a destination point in another country. They may be supplemented by national tickets for connecting journeys to the departure point and from the destination point and linked to form a single (through) ticket. See also “domestic tickets in foreign sales”.
Interruption of journey	Any discontinuation of journey except for a transfer from one train to another successive train.
Issuing undertaking	Undertaking issuing a ticket and usually receiving payment. May be also the same legal entity acting as Carrier  The issuing undertaking is responsible for handling requests for refunds or delay compensations.  The issuing undertaking is indicated on the ticket with its (RICS) code and, where appropriate, its logo or abbreviation. Usually, an undertaking responsible for stock control in case of paper tickets.
NRT [Non (integrated) reservation ticket]	Ticket without an integrated reservation valid on any (NRT) train of the same carriers serving the route marked on the ticket within a defined validity period. Reservations may (in some cases must) be purchased together with the ticket.
Offer	A product sold by an issuing undertaking for a specific tariff with defined conditions of use.
Online purchase/sale	Ordering tickets or purchase online including payment and creation printing of the ticket online.

Participant ticket	Paper or card document for members of a group travelling together.
Passenger	The person who intends to make, or is making, or has made a journey using the transport services and other services of one or more Carriers. May be different from the Customer
PNR	Passenger Name Record A record in the database that contains the information of a passenger, or a group of passengers travelling together.
PRM	Person with Reduced Mobility According to PRR, this means any person whose mobility when using transport is reduced due to any physical disability (sensory or locomotory, permanent or temporary), intellectual disability or impairment, or any other cause of disability, or as a result of age, and whose situation needs appropriate attention and adaptation to his or her particular needs of the service made available to all passengers.
PRR (Passengers Rights Regulation)	Regulation (EC) 2021/782 of the European Parliament and of the Council of 29 April 2021 on rail passengers' rights and obligations.
Railway Undertaking (RU)	Legal entity which offers passenger and/or freight rail transport services. It is a private or public organisation holding the licences and certificates which public law defines as necessary and provide traction for trains.
Refund fee	In case of cancellation of the travel the fee reducing the amount of the refund (containing the cancellation and handling fee together)
Reservation ticket	Document which holds a reservation. A reservation ticket is not a travel ticket unless it is a "ticket + reservation".
RID	Regulation concerning the International Carriage of Dangerous Goods by Rail (RID – App. C to COTIF)
RPT	Rail Pass Ticket. E.g. Eurail passes, Interrail passes, national passes.
SCIC-EWT	Special international conditions of carriage for journeys using East-West-traffic Tickets
SCIC-IRT	Special international conditions of carriage for tickets with integrated reservations.
SCIC-NRT	Special international conditions of carriage for tickets without integrated reservations.
SCIC-NT	Special international conditions of carriage for journeys using Night Trains
SCIC-RPT	Special international conditions of carriage for rail pass tickets.
Single commercial transaction	A single commercial transaction means the purchase of one or more tickets at the same time and through the same distribution channel according to the carrier's (railway undertaking's) timetable proposal, leading to one single payment. It does not constitute a single commercial transaction contract of carriage if, despite respecting the single payment obligation: - a customer for an intended entire journey autonomously splits this entire journey into separate journey segments and/or does not respect the connection time between the individual journey segments proposed in the timetable offer

Single contract of carriage (syn. through-ticket)	Contract of carriage which covers the carriage of the passenger from his/her departure to destination point represented by one or several tickets purchased within a single commercial transaction or within the scope of the options agreed by the carriers if the carriers' special conditions of carriage specifically provide for that.
Special conditions of international carriage (SCIC)	Conditions which carriers set down, individually or jointly, for certain international routes or for an international market union to supplement the general conditions of carriage GCC-CIV/PRR.
Standard Fare	The normal price without any reduction.
Special Conditions of International Carriage (SCIC)	Conditions which the carriers, individually or jointly, lay down to supplement the GCC-CIV/PRR for certain routes or within an international business unit.
Service charges	Charge which may be made by the issuing undertaking (or its agents) for issuing the ticket. It must be shown on the ticket itself or stated on a separate document.
Sleeping car compartment	A sleeping car compartment contains maximum 4 beds and a washbasin. It can be bookable as 4 (Quadruple), 3 (Triple), 2 (Double) or 1 bed (Single) compartment. Some sleeping car compartments contain shower and/or toilet (e.g. called Deluxe/Premium) which is published by the service operators.
Substitute carrier	A carrier who has not concluded the contract of carriage with the passenger but to whom the carrier has entrusted the execution of the rail carriage contract in total or in part. See Article 3b CIV. The substitute carrier is not liable in PRR cases. It is joint and severally liable together with the contractual carrier in cases of death and injury to passengers (Article 26 § 5 CIV) or for the transport of registered luggage - cars on auto trains included - (Article 39 § 4 CIV). Substitute carrier(s) is not shown on the ticket.
Successive carrier	Carrier in a chain of carriers who perform the contract of carriage with the passenger and who are liable for the performance of that contract. Successive carriers are shown with their 4-digit RICS codes on the tickets.
Supplementary ticket for a night train	Ticket which is issued in addition to the travel ticket(s) and contains the data (e.g. date, time, price, etc.) of the required service category.
Tariff	System of fares with a specific pricing schema.
Tariff Code	A numerical code for booking an offer in the electronic reservation system
Through ticket	Single contract of carriage for successive railway services operated by one or more railway undertakings.
Ticket	Valid evidence, regardless of its form, of the conclusion of a contract of carriage.
Train category	The category of service and traffic operation of a train (e.g., EuroNight, nightjet).
Travel agency	A legal entity which sells rail tickets in the name of and for the account of the carriers, possible in combination with other travel services.

## Introduction

### Object of this tariff

- 1 This tariff includes joint conditions of carriage for all sleeping car and couchette-coach services that are performed by RUs that are parties to this tariff. Within the COMMERCIAL FIELD of those RUs. It also includes special terms for specific sleeping car services. The terms of the SCIC-NRT apply mutatis mutandis to trains that run overnight but have seated coaches ("day coaches") only.

The introduction of this tariff, any amendments and additions to it, and any cancellation of it shall be made public by the RUs in the manner prescribed for them.

Terms that apply to both sleeping cars and couchette coaches are printed over the entire width of the page.

Terms that apply to sleeping cars only are printed on the left side of the page.	Terms that apply to couchette coaches only are printed on the right side of the page.

Terms that apply to the seated coaches of night trains are printed in the centre of the page below the terms for sleeping cars and couchette coaches.

### Participating and affiliated RUs

- 3 Participating RUs are those who operate night trains services. Affiliated RUs are those on whose operate neither sleeping nor couchette cars travel, but which sell services on behalf of participating RUs.

### Basis in transport law

- 4 Unless specified otherwise below, the legal basis for transport in accordance with this tariff is the GCC-CIV/PRR, the terms of the Special Conditions of International Carriage for Non-integrated-Reservation Tickets (SCIC-NRT) and the terms of the Special Conditions of International Carriage for Integrated Reservation Tickets (SCIC-IRT).

### **Scope of validity**

- 5 This tariff shall apply to all RUs that are parties to the SCIC-NRT and SCIC-IRT, with regard to the use of seats/berths in sleeping cars and couchette coaches running on routes of at least two RUs.

The tariff shall also apply if an RU issues reservation tickets for the domestic routes of another RU or for a third-party RU's coach that is running on the first RU's domestic routes.

## Section A INDIVIDUAL PASSENGERS

### Publishing of coach service

- 6 Trains that run with sleeping cars and/or couchette coaches are published in the timetable of the RUs on whose territory they run. The taking up and setting down of passengers may be limited during the night.  
After the last station stop from which reservations can be purchased, no berths or couchettes shall be allocated to passengers who do not have reservation tickets unless there are compartments that have unoccupied berths or couchettes.

### Berth classes and supplements

- 7 Depending on the coach type used, passengers can choose among

- 8 For trains where ticket and supplement is not issued in one ticket (NRT ticket + supplementary ticket) passengers being transported for a reduced fare or for free shall also pay a full supplement. For the use of certain couchettes and sleeping cars, a reduced supplement is charged for passengers who are exempt from paying the full supplement. The reduced supplement is specified in the section E.
- The RUs shall be entitled to use bilateral and multilateral agreements to specify couchette and berth supplements that deviate from those listed in the section on couchette and berth supplements. One of the participating RUs must be the manager of the service. The connection must be exclusively within the territory of the RUs that are parties to the agreement.

The supplement shall always be paid when the seat/couchette/berth is ordered; a seat/couchette/berth reservation fee shall not be charged.

For travel in sleeping cars or couchette coaches on certain connections, "RIT" fares ("Rail including tours" with certain travel organisers) are charged as per the RIT guidelines.

Reservation tickets shall not be given to passengers unless the allocated seat/couchette/berth is marked on the tickets; passengers shall be given receipts for written seat/berth requests.

IRT (Global Price) tickets apply to some sleeping car and couchette-coach services. Each IRT price package includes a ticket; a berth, couchette or seat supplement (also known as a surcharge); and a reservation.

### **Coach classes and tickets**

- 9 A reservation ticket and a ticket for the right train category and comfort class, valid for the section of the route to be spent in a sleeping or couchette car, is mandatory for using a night train.

The following rules apply:

In case of IRT (Global-Price) tickets:

All prices and supplements for using the different comfort classes and its services are included in the price of the IRT (Global-Price) ticket.

In case of NRT (tickets without integrated reservation of a seat or berth) or Rail Pass (RPT) tickets:

A second class NRT or RPT ticket in connection with a proper reservation for the desired comfort class is sufficient for the use of all night train comfort categories (seat, couchette, sleeping car), except for the Deluxe categories (as described in Nr.7).

For the use of a Deluxe cabin a first class NRT or RPT ticket is mandatory.

Exceptions from these general rules, valid for the trains of some carriers, are to be defined in the chapters of the special conditions of carriage for these carriers. (Section C). If such an exception is set, it applies for the entire route of the train.

### **Sleeping car and couchette availability on board**

- 10 IRT (global price) tickets or NRT ticket and reservation supplement for sleeping and couchette car shall be sold by various distribution channels. After the departure of the train upgrading the service level (e.g. from seat to couchette, from Triple to Single, etc.) depending on the available places and can be bought on board from the attendant.

An IRT price (global price) shall be charged on board for trains that use the global price system.

Payment for on-board sales shall be accepted in the currency specified on the sleeping or couchette car ticket or in the equivalent amount in another currency related to the OD or the route of the train.

### **Seat/berth ordering and allocation**

- 11 The terms of the SCIC-NRT apply to the ordering and allocation of seats/berths.

The terms of the special motorail trains apply to sleeping and couchette cars on motorail trains.

For reservations that cover two nights, one sleeping car or couchette supplement shall be issued for the entire journey.

### **Occupation of an entire compartment**

- 12 Passengers who wish to have a multiple-berth compartment to themselves shall pay the full, adult rate, as specified in the tariff, for applicable supplements and tickets for unoccupied seats/berths.

<p>This principle shall apply even if a passenger does not show up and a TRIPLE compartment reserved for three persons travelling together remains occupied by two persons who wish to have the compartment to themselves. If it is less expensive to buy two tickets and two Double supplements, then one or three tickets, whichever applies, and the three Triple supplements must be refunded and two new tickets (if first class is desired) and two Double supplements issued.</p>	<p>In compartments sold for four persons, four couchette places shall be considered to be offered even if six or five are available.</p>

**Changing of seats/courette/berths ordered**

- 13 An exchange shall be considered a return and new booking in accordance with section 26.

When berths and couchettes ordered on motorail trains are changed, the same conditions shall apply to passengers who are bringing a car as apply to car places in accordance with the special SCIC-NT tariff on motorail trains.

The conditions of the present tariff shall apply to passengers who are not bringing a car.

**Extension of route travelled, changing of seat/courette/berth type**

- 14 If a passenger who already has a reservation ticket would like to travel further than the destination station marked on the ticket or in a higher service level

then the value of the original sleeping car or courette ticket is to be applied in full to the price in the desired sleeping or courette car, and any difference in the supplements is to be charged subsequently.

Depending on the ticket and reservation type (IRT or NRT + supplementary ticket) the SCIC-NRT or SCIC-IRT apply to the ticket.

If a coach is cancelled and the only option is to assign a passenger to a higher service category, the passenger shall not be subsequently charged for the difference between the original price of the category and the higher price of the service category or for the difference in fare.

For missed connections confirmed by the RU and in other cases in which the RU is at fault, the terms for coach cancellations shall apply mutatis mutandis.

If the berth or courette a passenger booked cannot be allocated to him/her due to reasons for which the RU providing the coaches is at fault (technical disruption, coach not provided), a courette or berth in the same comfort class and/or category shall be allocated to the passenger if possible. If this is not possible, the passenger shall be either upgraded to a courette or berth in a higher comfort class and/or category or downgraded to a courette or berth in a lower one. In the event of an upgrade, the passenger shall not be subsequently charged for any difference in price between the reservation charges for the different comfort classes and/or categories; in the event of a downgrade, the passenger shall receive a refund for any difference.

These rules shall also apply if the passenger must be relocated to a coach of another RU on the same train.

If the service supplier allows:

- a Single compartment is used by two/three persons or
- a Double compartment is used by three persons

and the second person is over ten years of age, the sleeping car attendant shall issue a new berth ticket at the full price based on the number of berths actually being used, and on the new berth ticket the attendant shall make note of the number and issuing RU of the original one. The original berth ticket shall be withdrawn.

The value of the original berth ticket on the day on which the exchange is made shall be credited towards the newly issued berth ticket, up to the latter's value.

If the value of the newly issued berth ticket is greater, the passenger shall be charged for the difference.

If the value of the newly issued berth ticket is lower, the number and class of the berths actually being used shall be noted on the receipt for the original berth ticket or on the certificate to be issued as a replacement. The passenger shall submit the ticket for a refund.

## Children

- 15 The specifications of travelling of children based on section 12.3 of the SCIC-NRT or point 13/a SCIC-IRT shall apply when berths and couchettes are used by children.

The specific regulations for child ticket necessity, fare supplement, maximum age of sharing a bed and minimum age of travelling alone can be found in section D.

## Accommodation of different genders

- 16 The following shall apply for the accommodation of **different genders** unless the passengers book the whole compartment.

<p>A multiple-berth sleeping car compartment may be used together by persons of the same gender only, <i>but some RUs provide only mixed compartments for all genders and compartments for women.</i></p> <p>Conditions for children are published on special pages</p>	<p>RUs shall not be obligated to provide separate men's or women's compartments in couchette coaches.</p>

## Seat/berth occupation and use

- 17 The right to a reserved sleeping car or couchette place shall expire if it is not asserted within the first 15 minutes after the train has left the station from which the passenger reserved the couchette or sleeping car.

RUs reserve the right in special cases to assign passengers to different berths or couchettes than the ones specified on the passengers' sleeping car or couchette tickets.

If allocated seats/berths cannot be kept available, the orderer shall be entitled to a refund of the supplement only.

- 18 The following terms shall apply to sleeping and couchette car, based on the time of day:

Sleeping and couchette car in sleeping cars shall be put into a reclining or sitting position, depending on the time of day, if technically possible.



The sleeping or couchette car attendant is instructed to set up the berths at the request of passengers, in the order in which the requests are made.

With passengers' consent, their tickets and – if the conditions imposed by the border-control authorities do not specify otherwise – travel documents may be collected and kept safe by the attendant to show at the border control.

Passengers may request that they be woken.

From 9:00 pm, passengers using a compartment shall not be entitled to object to the couchettes/berths being set up if one of the passengers wishes to go to bed. In general, the couchettes/berths shall be set up from 10:00 pm without a request being necessary.

The main lighting must be switched off in the compartments set in their night-time position.

Passengers shall not be entitled to object to their compartment being set into day-time position after 10:00 am, if one of the passengers using the compartment wishes.

### **Hand luggage and bicycles**

- 19 Hand luggage shall be accommodated in the areas provided for it, in such a way that it does not bother other passengers. Luggage may not be placed in the aisles or in neighbouring compartments.

Passengers may not travel with sledges or other larger sports articles in sleeping cars or couchette coaches. Passengers may bring skis with them in these coaches. Skis shall be accommodated so that they are out of other passengers' way as much as possible.

The RUs that own the couchette coaches shall be entitled to impose special terms on the carriage of sledges, skis and other larger sports articles in their coaches, from their stations only.

For bicycles the regulation of nr. 15 SCIC NRT or point 13. g SCIC IRT applies. Bicycles are not allowed in sleeping or couchette carriages. The folded up bicycles which can be accommodated on the available luggage space are excluded from this rule, if they do not harm, disturb or affect other passengers.

Special conditions of service operators' bicycle carrying can be found on in section D.

### **Smoking**

- 20 Smoking shall be prohibited on all night trains.

### **Animal policy**

- 21 Dogs and cats may be brought along in sleeping cars and couchette coaches if tickets and reservation tickets for a compartment for individual use in accordance with section 12 are purchased for the owner and any accompanying persons. The applicable fare for dogs shall also be paid. Section 16 of the SCIC-NRT shall apply to the transport free of charge of guide dogs for the blind (see special agreement) and service dogs of severely disabled persons (documentation may need to be shown on board).

An animal brought on board a night train must be supervised by its owner. The owner shall be liable for any damage caused by the animal. For necessary cleanings a fee can be raised.

Bringing other animals on board night trains is generally prohibited.

The RUs participating in night trains shall be entitled to impose other conditions generally or in specific cases. The passengers are liable to find out about these conditions on their own.

Special conditions of transporting animals can be found on in section D.

### **Presence in sleeping and couchette cars**

- 22 Passengers who do not have reservation tickets shall be prohibited from staying in sleeping car and in couchette coaches. This rule extends to aisles and platforms.

Exceptions shall be made for pressing reasons and on a case-by-case basis only.

Provisory of divergent rules of the RUs, night's rest as a rule is between 21:00 hrs in the evening and 07:00 hrs in the morning. In this time the passengers have to behave in such a way that fellow-passengers are not disturbed. In particular noise pollutions (e.g., by loudly talks, playing of music etc.) are to be avoided. The sleeping car / couchette car personnel is obliged to implement this rule. Passengers who do not obey this rule and do not change their behaviour upon request, may be expelled from the train. In such cases these passengers are not entitled for a refund of the fare or the booking fee.

**Switch from couchette to sleeping car**

- 23 The value of a reservation ticket that has been purchased but not used may, by mutatis mutandis application of the terms provided in section 14 concerning the changing of seats/berths ordered, be credited towards a berth supplement of a berth ticket to be purchased for the same connection. Only one couchette supplement may be credited towards each berth.

A passenger who possesses a ticket and seat/berth reservation in a cancelled couchette coach and who must move to a sleeping car shall not be made to subsequently pay for the supplement.

If a passenger wishes to have a berth in a higher berth class than the one offered, he/she must pay the difference in supplements between the two berth classes.

The couchette supplement already purchased shall be credited towards the additional purchase in both cases.

**Replacement and extra coaches**

- 24 For extra coaches, the supplement shall be charged based on the type of coach used.

<p>If a replacement coach is used, the berth supplement shall be based on that coach. No additional price shall be charged if a passenger is assigned to a higher berth class.</p>	<p>The couchette supplements charged for extra and replacement coaches shall be identical to those for the regular coaches.</p>
--	---

If a sleeping or couchette car is used as a replacement coach, and a passenger must take a berth that has a lower fare than the fare for the passenger's berth ticket, the sleeping car or couchette-coach attendant shall make note of this fact on the reservation confirmation.

### **Seat/couchette/berth cancellation**

- 25 All issuing offices shall accept seat/berth cancellations if the reservation system allows it.

Refund can be asked for at the ticket issuer company. Conditions of refund can be found in Section D.

If a berth or couchette ticket applies to more than one person and only some of the seats/berths are cancelled, the following procedure shall be followed:

The remaining seats/couchette/berths shall be processed in accordance with the terms imposed by the RU in question.

### **Ticket refunds**

- 26 If an unused reservation ticket is returned:

- The full amount of the supplement shall be refunded if the RU bears responsibility for the seat/berth's not being used (e.g. the sleeping or couchette car was cancelled, a connecting train was late, service was interrupted, the same seat/berth was reserved for more than one person, or there were no attendants or sheets, blankets, etc. in the couchette car) and the RU or the sleeping car or couchette-car attendant has certified this fact.

The RUs shall be entitled to impose other rules for their issuing offices for peak traffic times. Other terms and conditions apply to special global price offers. Please refer to the section on connections and special conditions.

If a special sleeping or couchette car is not cancelled seven or more days before the day of departure, no right to a refund of the supplements shall apply.

No additional deductions (processing cost, postage for transfer) shall be made.

Refund requests shall always be addressed to the RU that issued the supplement.

In addition to the ticket refund a handling fee may apply by the issuer/distributor.

Special conditions of supplement/IRT ticket refunds can be found in section D

**Passenger rights and liability for delayed or cancelled trains**

- 27 This information comes as a reference to point 10. GCC-CIV/PRR, as of June 7<sup>th</sup>, 2023: point 10. GCC-CIV/PRR (2023). with the following additions, shall apply when trains are delayed or cancelled:

If a berth or couchette cannot be used because of delay, train or coach cancellation or any other reason, the passenger shall be entitled to a full refund of the berth or couchette supplement the passenger purchased. If the trip is no longer worthwhile for the passenger, he/she shall also be entitled to a refund of the fare paid,

If the passenger cannot be provided with the berth or couchette booked, and instead only with a berth or couchette in a lower berth, comfort or coach class, the passenger shall be entitled to a refund of the difference in price between the berth or couchette booked and the one provided.

**Collection of supplement charges, advance payments**

- 30 Special conditions of travel of groups in regular sleeping and couchette cars can be found in Section D

Depending on the technical conditions, one joint reservation ticket shall be issued for each travel group, provided all the group members are travelling in the same coach and have the same type of seat/berth. If the group members are accommodated in multiple coaches or in different types of seats/berths, one reservation ticket shall be issued per coach and type of seat/berth. If multiple reservation tickets are issued, a note shall be added under the number of each reservation ticket specifying the number(s) of the corresponding ticket(s).

**Seat/couchette/berth cancellation**

- 31 Exchanges for groups shall be performed in accordance with section 13.
- 32 The terms for refunding supplements are specified by the service operator what can be found in section D.

## **2. Tickets**

All trains listed in Article 1 can only be booked with Integrated Reservation Tickets (IRT).

The Integrated Reservation Tickets (IRT) includes the fare for the journey, the reservation in the respective travel category as well as additional services (only in couchette and sleeper cabins) and is only valid for the booked train, travel day and route section.

All travel categories can be used with 2<sup>nd</sup> class tickets.

In principle, tickets are sold 180 days in advance. This period can be shorter for travel dates from mid-December due to the European timetable change and also all year round due to operational restrictions such as construction works and route closures. Despite these restrictions, in most cases booking is possible via [www.nightjet.com](http://www.nightjet.com), while all other sales channels are closed.

The departure and arrival time shown on the booked ticket may change at any time for operational reasons. Therefore, the correct departure time of the train must be checked before starting the journey (e.g. at [www.nightjet.com/my-journey](http://www.nightjet.com/my-journey)).

The booked seat/berth/bed on the train must be occupied not later than 15 minutes from departure; thereafter the claim to the booked place ceases to apply. Train staff are then entitled to assign these places to other customers.

### **Accompanying person**

The accompanying person of a wheelchair user, travelling together in the wheelchair compartment, is included in the ticket of the wheelchair user. The person accompanying the wheelchair user does not need any further reservation or tickets.

All other companions of disabled passengers, whose certificate of disability bears the comment "The holder of this pass requires an accompanying person" need to book a chargeable reservation.

All persons with reduced mobility have to pay a ticket at the most favourable, generally available rate.

### **Rail inclusive Tours (RIT)**

All tour operators are permitted to issue RIT tickets as part of an all-inclusive package for night trains, which must include at least one overnight booking. The rail ticket and the overnight booking must be offered by the same organiser. When presenting an RIT ticket on the train, proof of the package arrangement must be provided by the customer. This can be done by

showing the total invoice or the travel documents. If this proof cannot be provided, the customer shall be treated as a passenger without a valid ticket. No fare is shown on the RIT ticket (TC 94 RIT Adult, TC 95 RIT Child; conditions like Sparschiene Comfort).

### **5. Animals**

Dogs may only be taken along if the owner and any accompanying persons have tickets for an entire compartment (seat, couchette or sleeper car) for their sole use. For each trip, a “dog ticket” must be purchased on the train. Guide dogs and assistance dogs are carried free of charge. In the Mini Cabin no dogs are permitted.

Other small and non-dangerous animals may be carried free of charge in closed and secure containers, provided that the containers are of the same size as the luggage and that they can be placed in the luggage racks. Even with a container, you may only take your pet into the compartments of sleeping and couchette cars if you have booked the entire compartment.

### **6. Luggage & Bicycles**

You can take luggage with you on trains free of charge, provided it is stored in the luggage racks above or below your seat or in the areas designated for hand luggage. Luggage must not exceed a maximum dimension of 90 cm x 60 cm x 40 cm.

Bicycles require a reservation for which a fee applies. You can find out which trains offer bicycle transport at [www.nightjet.com](http://www.nightjet.com).

Folded folding bikes and scooters with a maximum dimension of 90 cm x 60 cm x 40 cm are carried free of charge on all trains, if they can be stored in the luggage storage area in the booked compartment and do not obstruct or block other passengers or the train's security systems.

### **7. Changing the travel category on board**

The travel category (seat, couchette or sleeper car) on board of the Nightjet can be changed against a surcharge, if free places are available. Information is available from the team of train attendants.

### **8. Exchange / refund**

An exchange must be treated as a refund. Interruption of travel is not permitted.

No reimbursement is available for partly unused tickets.

All returned tickets must be reported as free via the reservation system.

### **9. Other information**

The quiet time at night must be observed on the Nightjet trains between 9 p.m. and 8 a.m.

### **10. Prices**

For the carriage of child under 6 years (5,99) for whom a separate berth/couchette/seat is requested and who is travelling with an adult who holds a ticket and a reservation (seat, berth or sleeping place) a supplement/reservation are required. In this case, a separate ticket for the child is not required. In the case when more than one child is travelling with an adult and a separate berth/couchette/seat

is requested for the another child then a NRT ticket for a child (a 50% discounted NRT ticket) and a supplement/reservation are required.

Children from 6 to 16 years (15,99) are given a 50% discount on the full NRT ticket price.

One berth/couchette can be shared between two children under 10 years or between an adult and a child up to 10 (9,99) years.

If two children under 6 years share one bed, one of the children must have a NRT ticket for a child (50% discounted NRT ticket) with the supplement.

**In case of IRT trains (which are indicated in point 13 below):**

**10. Exchange and refund**

The refund of couchette/sleeper is possible by the issuing carrier only. Following rules are applied:

- if the place has been cancelled latest 1 day before departure, the fee for refund is 10%, min. 3 EUR for place and night.
- if the place has been cancelled in the day of departure (before departure), the fee for refund is 50%, min. 3 EUR for place and night.
- if the place has been cancelled after departure or hasn't been cancelled at all, there is no entitlement for any refund

**11. Other information**

On both trains no. 407/477 from Warsaw to Budapest and 476/406 from Budapest to Warsaw, in cars belonging to PKP IC, tickets are not sold on board the train.

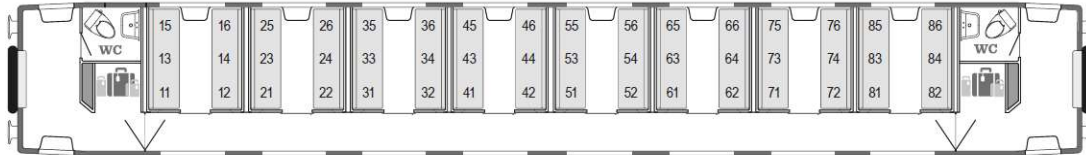
Snälltåget international seating carriage Bmpz:
